UPDATE FROM PAUL DWYER AND JOHN ELLIS:

Hemlock and Livonia Fire Departments have collaborated together, and hope to put final implementations in 2026. While legalities continue, Livonia will be on call for all calls, and Hemlock will respond as well when the resources are available. Phase two is to decide whether to merge, or to consolidate. With a merge, Livonia would remain intact as is, and absorb Hemlock. Hemlock would go through a dissolution. With this option the Joint Town and Village Board would continue to appoint commissioners. With a consolidation, both departments would need to dissolve and then join as one. The Livonia/Hemlock Fire District. In this scenario, all commissioners would be elected and it would be a weighted ballot. This would be the more expensive option of the two, given that two districts would need to dissolve

completely and be re-built. The Town Board was asked what option they think would be the best, and how they would like to move forward. Ideally, the fire departments would like to have the Board appoint the new commissioners in July of 2026, should a merger be the option they choose. The Board stated they would like to re-connect on this in the coming months with the new Town Board Members. Supervisor Gott applauded the collaboration and initiative that Hemlock and Livonia have taken to do what is best for the taxpayers. John Ellis reported that Lakeville invited them to an open meeting, and advised they intend to continue to rely on Livonia for mutual aid and are not interested in any type of merger. Supervisor Gott asked what should happen if Lakeville decides to change their mind in the future. John Ellis advised that they would have to start all over, and currently Hemlock and Livonia are eight thousand dollars into this project already.

Superintendent Dwyer advised he has an opportunity to purchase a new box to put on an older 10-wheeler dump truck. It will need to be powder coated and have a new chassis. The total cost is approximately \$40,000 which was not budgeted in his equipment line for next year. He is asking to exceed next years equipment budget by approximately \$40,000 to update an older truck to extend its life and longevity vs replacing for upwards of \$300,000. He also told the Board there is a significant amount of money coming back from the state this year, so the money will be there, he just wants to allocate it properly. Supervisor Gott stated they can just make a budget transfer in 2026 at the end of the year as he will have the extra from this year. The Board thinks it is the fiscally appropriate decision to invest in this, rather than needing to plan to replace the dump truck.
