## LOCAL LAW #2-2025

### Village of Livonia, County of Livingston

A local law amending certain portions of Article 3 of the Code of the Village of Livonia, restricting on-street parking on West Avenue and Ward Avenue, and modifying restricted parking on Spring Street in the Village of Livonia.

#### Section 1. Legislative Intent

It is the intent of this local law to prohibit on-street parking that obstructs the free passage for other vehicles using the Village streets.

#### Section 2. Legislative Authority

This local law is enacted pursuant to the Village Law and General Municipal Law of the State of New York for the control and safety of the residents of the Village of Livonia with regard to motor vehicles on village streets.

#### Section 3. Code changes.

Sections 142-12 of the Code of the Village of Livonia is hereby replaced and superseded in its entirety and replaced with the following provisions:

#### 142-12. Prohibited Parking

The parking of vehicles is prohibited in the following locations:

<b><u>Name of Street</u></b>	<b><u>Location</u></b>
Big Tree Street	Both sides
Bowen Parkway	West side
Branch Street	West side
Church Street	North side from the Prettejohn Lot to Spring Street
Grove Street	Both sides
High Street	East side
Linden Street	East side from Main Street to North Street
School Street	Both sides from Commercial Street to Branch Street
School Street	North side from Branch Street to Spring Street
Spring Street	East side from Main Street to Puppy Lane
Ward Avenue	Both sides from Commercial Street to West Avenue

West Avenue

Both sides from Route 15/20A to the end of  
West Avenue

#### Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstances, directly involved in the controversy in which such judgment or order shall be rendered.

#### Section 5. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.
