INTERMUNICIPAL AGREEMENT

This Agreement made this ____ day of ______, 2021, by and between the **TOWN OF LIVONIA**, a municipal corporation organized and existing under the laws of the State of New York with offices located at 35 Commercial Street, Livonia, New York, and the **VILLAGE OF LIVONIA**, a municipal corporation organized and existing under the laws of the State of New York with offices located at 36 Commercial Street, Livonia, New York.

RECITALS:

WHEREAS, the Town of Livonia (hereafter "Town") is a duly incorporated town pursuant to the laws of the State of New York; and

WHEREAS, the Village (hereafter "Village") is a duly incorporated village pursuant to the laws of the State of New York; and

WHEREAS, the Town has various properties, and facilities serving those properties, that require periodic lawn maintenance, snow removal and salting to prevent ice; and

WHEREAS, the Town does not have the proper equipment or sufficient staff to efficiently provide such periodic lawn maintenance, snow removal and salting to prevent ice on all of the Town's various properties; and

WHEREAS, the Village maintains a Department of Public Works (hereafter "DPW") that is adequately staffed and has proper equipment to provide periodic lawn maintenance, snow removal and salting to prevent ice on certain properties of the Town; and

WHEREAS, the Village has the capacity to provide such services to the Town in an efficient manner; and

WHEREAS, the Village and the Town desire to memorialize in this Agreement the respective obligations of the Town and Village with regard to the Village providing such services to the Town; and

WHEREAS, the Town Board of the Town of Livonia and Village Board of Trustees of the Village of Livonia have independently reviewed and considered the issues relating to the Village's Department of Public Works providing services to the Town, and severally determined that it is in the best interests of each municipality, and the joint and mutual interests of both municipalities, to enter into this Agreement.

NOW, THEREFORE for good and valuable consideration the receipt of which is acknowledged, it is hereby agreed as follows:

- 10. The parties agree that each shall indemnify and hold the other harmless from any liability, claim, damage, injury or other cost associated with or resulting from its respective obligations under this Agreement.
- 11. This Agreement shall be governed by the laws of the State of New York.
- 12. The Agreement sets forth the entire understanding between the parties on the subject matter set forth herein and may be changed only in a writing signed by the parties.
- 13. This Agreement may be executed and delivered (a) in any number of counterparts, with the same effect as if the parties hereto had signed the same document, and all of which counterparts together shall constitute one and the same fully executed agreement, and/or (b) by a PDF version provided by facsimile or email.
