June 23rd, 2021

Present: Mayor Cal Lathan, Cindy Pfeifer, Chris Hoffmann, Adam Backus, Julie Holtje, Dan Coon, Bill Kurtz and Annette Meade. Plus Chris Genthner.

Mayor Cal Lathan called the meeting to order at 7:00.

M/2/C (D. Coon, B. Kurtz) to approve the minutes from the June 9th, 2021 meeting. Passed 4 to 0. Mayor Lathan stated that the highlight of the 6/9/21 meeting was the compliments that Rob Dewey extended to Chris Hoffmann and his DPW crew.

M/2/C (A. Meade, D. Coon) to approve the payment of claims #12 through #15 and also claims #16 through #24 in the amount of \$8,192.76. Passed 4 to 0. There were no comments.

A dialogue with Planning and Zoning Officers – Adam Backus and Julie Holtje **Housing Proposal for property adjacent to Bowen Park

Adam informed the Board that a four – lot subdivision has been proposed for the land that is East of the entrance to Bowen Park. Curb cuts were discussed. The road into Bowen Park could be used and improvements made. The right of way might be used for Emergency Vehicles only. Annette Meade asked about the timeline for development.

** Moran House on Big Tree ("Zombie House")

The owner is living out of state. The house is in serious disrepair, the porch has fallen down and the garage roof has collapsed. It is difficult dealing with issues related to a vacant house despite the potential for various hazards. The taxes have been paid on this property.

Chris Genthner arrived at 7:15 pm.

Adam explained that the Village Board does have options regarding this property. The Village could purchase the property, sell it and pay back legal fees that this might incur. The County Land Trust and Ian Coyle are aware of the condition of this property which might qualify for demolition. Chris Genthner asked about any

contact with the current owner. Annette Meade said that she knows a family member who she will contact with a friendly approach to see if there is the possibility to work on this situation. The current Property Value is \$27,000.

**Signage, Local Law, Code Changes

Adam detailed various situations that make enforcement difficult.

Annette Meade and Chris Genthner agreed to help Adam with new code changes to be presented to the Town of Livonia Board. Various Signs and Awnings on several local businesses were discussed.

Establish July 14th, 2021 as the date for the Public Hearing on the LCWSA/ Village Agreement.

M/2/C (C. Genthner, B. Kurtz) to establish July 14th, 2021 as the date for the Public Hearing regarding the Livingston County Water & Sewer Authority and Village of Livonia Lease Agreement. Passed 5 to 0.

Notice for Public Hearing

M/2/C (A. Meade, B. Kurtz) to approve the Notice for Public Hearing that will be published. This Public Hearing will be held on July 14th, 2021 at 7:00 pm at the Livonia Village Office on Commercial Street. The Public Hearing is to consider the adoption of the Lease Agreement between the LCWSA and the Village of Livonia. Please find a copy of this notice attached. Passed 5 to O.

A first look at the Lease Agreement between the LCWSA & the Village of Livonia. Mayor Lathan mentioned that the new C.E.O. of LCWSA is Jason Molino.

There was a short discussion pertaining to the specific wording under the heading of Rights and Obligations of the Water Authority. Section 2.4, The Authority shall sell water to the customers of the System in accordance with the current Village rate schedule, including the unit basis, through 2028, etc.

Also reviewed the specific wording under the heading of Rights and Obligations of the Village. Section 3.7, The Village shall remain responsible for payment of all existing debt service, if any, associated with the system.

The Village of Livonia Board agreed that the Communication of Emergencies to Village Residents is very important. The Board stressed that they want Village Residents to continue to be made aware of water service disruptions.
